During the Roman period, specifically in the fourth century A.D, the schools of Thagaste and Madauros were two of the most prominent ones in Algeria. They became well-known due to the nature of their educational programme applied in the learning process. These institutions represented a fundamental cornerstone in shaping and refining the intellectual character of a number of African literary elites who trained and studied there. Thanks to the strength of their instructions, these schools enabled writers to leave a clear imprint and a significant legacy on Latin literature.

The spread of these schools in Africa coincided with Roman policy whose objective was to establish such institutions throughout the settlements. This expansion aimed to meet the needs of Roman citizens and Italian settlers, while also serving as an instrument for the diffusion of Romanization among Africans. Through these schools, Rome sought to disseminate the ideals of the Roman cities and implement its settlement and pacification policy.

Access to education, however, was not open to all. It remained largely restricted to a specific social class – members of the local elite or the sons of landowners – who could afford the considerable expenses of schooling. Their primary motivation was to secure prestigious administrative positions for their children within the Roman system or to ensure their upward mobility within the Roman social hierarchy.

Child labour refers to work that children perform under the legal minimum working age or in conditions that harm their health, safety, or morals. It includes tasks that deprive them of their potential, dignity and education. Yet, not all work is considered child labour, age-appropriate chores or part-time jobs that do not interfere with schooling can be beneficial.

Deep social and economic issues force children to work, with poverty as the main cause. Families in hardship may depend on a child's income to survive, especially when adults cannot find decent work. Other factors include weak laws, cultural acceptance of child work, and crises like conflicts or disasters.

Child labour causes lasting harm to children's health, development, and future. Many work in dangerous places like mines, farms, or factories, where they are exposed to toxic chemicals, unsafe tools, and harsh conditions. This often leads to injuries, illness, or even death, with some children suffering permanent disabilities.

The damage is not just physical. Child labour also causes emotional trauma. Children may face abuse and stress leading to long-term mental health issues.

Despite years of campaigns, child labour remains a major global issue. However, by tackling the root causes of child labour, reporting exploitation, and demanding accountability, we can ensure all children have the chance to learn, grow, and enjoy childhood free of exploitation.
